### HURONTARIO LRT BACKGROUNDER

The Hurontario Light Rail Transit (LRT) Project is a provincially-owned system and that will bring fast and reliable rapid transit to the cities of Mississauga and Brampton along the Hurontario corridor.

Hurontario LRT will provide 18 km of rapid transit with 19 stops on a dedicated right-of-way and will link to GO Stations at Port Credit and Cooksville, the Mississauga Transitway, Square One GO Bus Terminal, Brampton Gateway Terminal, and key MiWay and Brampton Transit routes. It will primarily have a centre-running alignment with at least two vehicular lanes on both sides, cycle tracks and sidewalk, or multi-use trails, with the goal of creating a complete street.

Mobilinx, a consortium of local and international companies, will design, build, finance, operate and maintain the system. Selection of their proposal was the result of a comprehensive, open, fair and competitive procurement process observed by a third party fairness advisor.

Major construction is expected to begin in early 2020. Ongoing early works to move utilities began in 2017 and will continue until the start of major construction. The construction period is expected to bring impacts and disruptions to residents and businesses. The project team has committed to informing the public and stakeholders with as much notice as possible of potential disruptions.

Higher-order transit has been identified for the Hurontario corridor for decades, but in 2008, the Hurontario-Main Rapid Transit Project was identified in Metrolinx's 2008 regional transportation plan, The Big Move, as a priority project. In the following years, Master Plan studies, Business Case analyses, and an Environmental Assessment were conducted, eventually leading to the Province committing to funding the capital costs of the project.

Locally-assembled Alstom light rail vehicles will be utilized as part of Hurontario LRT.
